3	The member firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof.	18-07-2019 Thursday
4	The Secretary General shall display the provisional list of all members eligible to vote along with their National Tax Registration Number, Sales Tax Registration if applicable, the name and national identity card number of their representative at Notice Board and website of the Chamber.	22-07-2019 Monday
5	The members who have any objection to the entries/changes in the list of voters shall send their objections in writing to the Secretary General	29-07-2019 Monday
6	The Secretary General will intimate action on the objection or changes sent by members.	03-08-2019 Saturday
7	Any member aggrieved by the decision of the Secretary General, taken in the preceding clause, may make a representation to the Election Commission.	06-08-2019 Tuesday



18	The Regulator Trade Organizations shall decide the appeal preferred under the preceding clause. This clause ipso facto applies to the nominees of the women seats.	17-09-2019 Tuesday
