

18	The Regulator Trade Organizations shall decide the appeal preferred under the preceding clause. This clause ipso facto applies to the nominees of the women seats.	14-09-2020 Monday
19	The Secretary General will receive the withdrawal forms from the nominees completed by the nominees who want to withdraw from the Election.	16-09-2020 Wednesday
