3	The member firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof.	18-07-2022 Monday
4	The Secretary General shall display the provisional list of all members eligible to vote along with their National Tax Registration Number, Sales Tax Registration if applicable, the name & national identity card number of their representative at Notice Board & website of the Chamber.	22-07-2022 Friday
5	The members who have any objection to the entries/changes in the list of voters shall send their objections in writing to the Secretary General	29-07-2022 Friday
6	The Secretary General will intimate action on the objection or changes sent by members.	03-08-2022 Wednesday
7	Any member aggrieved by the decision of the Secretary General, taken in the preceding clause, may make a representation to the Election Commission.	06-08-2022 Saturday
8	The Commission will decide the representation.	11-08-2022 Thursday



17	Any candidate, aggrieved by the decision of the Election Commission, taken under preceding clause, where the Commission fails to decide within the time stipulated in the preceding clause may file an appeal to the Regulator.	07-09-2022 Wednesday
18	The Regulator Trade Organizations shall decide the appeal preferred under the preceding clause. This clause ipso facto applies to the nominees of the women seats.	14-09-2022 Wednesday
19	The Secretary General will receive the withdrawal forms from the nominees completed by the nominees who want to withdraw from the Election.	15-09-2022 Thursday
20	The Commission will issue final list of candidates.	16-09-2022 Friday
21	The polling at the registered office of the Chamber for Corporate Members .
