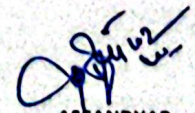

1	Approval of Schedule and Appointment of Election Commissions	14-07-2026 Tuesday
2	The Secretary General shall display election schedule on the notice board of GCCCI, website and submit a copy to the Regulator.	15-07-2026 Wednesday
3	The member firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof.	18-07-2026 Saturday
4	The Secretary General shall display the provisional list of all members eligible to vote along with their National Tax Registration Number, Sales Tax Registration if applicable, the name and national identity card number of their representative at Notice Board and website of the Chamber.	22-07-2026 Wednesday
5	The members who have any objection to the entries/changes in the list of voters shall send their objections in writing to the Secretary General	29-07-2026 Wednesday
6	The Secretary General will intimate action on the objection or changes sent by members.	03-08-2026 Monday
7	Any member aggrieved by the decision of the Secretary General, taken in the preceding clause, may make a representation to the Election Commission.	06-08-2026 Thursday
8	The Commission will decide the representation.	08-08-2026 Saturday
9	Any person aggrieved by the decision of the Commission or where the Commission fails to decide the representation within the stipulated time mentioned in the preceding clause may appeal to the Regulator, and decision of the Regulator in this regard shall be final.	11-08-2026 Tuesday
10	Regulator will decide the appeal.	25-08-2026 Tuesday
11	The final list of voters shall be displayed at notice board and at website of the Chamber and shall also be submitted to the Regulator	27-08-2026 Thursday
12	Any person who is eligible to contest the Election for the vacant posts of the Member Executive Committee shall send his nomination papers duly proposed, seconded by a duly registered voter and signed by the candidate, to the Secretary General on the prescribed form in accordance with the Articles of Association or Rules of the Chamber.	31-08-2026 Monday
13	The secretary General shall provide a copy of final list of voters to each contesting candidate.	01-09-2026 Tuesday
14	Scrutiny of the nomination papers and display a list of contesting candidates	01-09-2026 Tuesday
15	The objection if any, to the nomination of candidates can be filed to the Election Commission.	02-09-2026 Wednesday

16	The Election Commission will decide the objections filed under the preceding clause.	04-09-2026 Friday
17	Any candidate, aggrieved by the decision of the Election Commission, taken under preceding clause, where the Commission fails to decide within the time stipulated in the preceding clause may file an appeal to the Regulator.	07-09-2026 Monday
18	The Regulator Trade Organizations shall decide the appeal preferred under the preceding clause. This clause ipso facto applies to the nominees of the women seats.	15-09-2026 Tuesday
19	The Secretary General will receive the withdrawal forms from the nominees completed by the nominees who want to withdraw from the Election.	16-09-2026 Wednesday
20	The Commission will issue final list of candidates.	16-09-2026 Wednesday
