

- 3. GCCI to sponsor research on industrial need-based projects
- 4. GIFT University will facilitate partner organization in training for local industrialists on publicity, promotion advertising and public relations.
- 5. Mass Communication department to facilitate partner organization in documentaries, short films, publicity and PR content.
- 6. Cooperation in business, research and sharing of resources for the uplift of business activities inside the country
- 7. Joint efforts to mobilize resources for promotion of quality cultural and industrial education at the University.
- 8. Mass Communication department will facilitate the financially weak students on the recommendation of GCCI president.
- 9. GIFT University will invite GCCI member companies to its job fairs, seminars, workshops, training programs and other important events that would help them in business promotion.
- 10. Financial and/or funding consideration shall become the subject of specific discussion and agreement within the framework of separate implementation agreement.
- 11. No financial commitment, on the part of either signatory, is intended in or to be implied from this general document.







