



Memorandum of Understanding (MOU)



Between

PVTC (Vocational Training Institutes District Gujranwala) having its office at 204-Gill Road Gujranwala Contact Number 055-3730034, email vtigujranwala@pvtc.gov.pk, hereinafter collectively referred to as "PVTC Institute",

AND

The Gujranwala Chamber of Commerce & Industry, having its office at Aiwan e Tijarat Road Gujranwala, Contact Numbers: 055-9200391-4, 055-9200389 email: www.gcci.org.pk, hereinafter collectively referred to as "GCCCI"

1. Purpose and Scope

AND WHEREAS keeping in view their mutual interest, the Parties to this agreement intend to work together and enhance collaborative relationship for the promotion and joint function for cooperation in VTIs (PVTC) through Job/Career Fair, Enterprise Visit, Round Tables, Work Shadowing, Internship, Joint Planning Session and Orientation Session in order to enhance the productivity and competitiveness of local manpower for national development.

NOW THEREFORE this agreement witnesses as follows;

2. Terms & Conditions

- The duration of this agreement will be three years from July 01, 2021 to June 30, 2024.
- Nothing in this MOU will affect the statutory responsibilities of either party and if either party feels that this MOU is no longer appropriate to continue, they can give two month notice of termination in writing before the end of training session thereafter the MOU shall cease.

3. General Objectives

- Carry out joint activity (ies) as mutually agreed between the two parties including but not limited training programmes, workshops, orientation session, Job fairs, planning sessions etc.
- Collaborate to develop and execute industry-driven academic programmes and courses for better productivity of workforce.
- Ensure the classes, training and placement of VTIs (PVTC) trainees through on-job trainings, apprenticeships, traineeships, internships and job placements etc.
- Exchange information for monitoring purpose.

- Facilitation for job placements to graduates for improving the employment outcome.
- Utilize each other's' existing infrastructure and other facilities for achieving common identified
- goals on agreed terms.
- Facilitate in awareness raising/advocacy programmes, tracer studies, feedback sessions, assessments, site-visits, exhibitions etc. organized for the development and uplift of skills and placement in the country

4. Role of VTIs (PVTC):

Following activities may be conducted on mutually agreed terms and conditions:

- To work closely with Gujranwala Chamber of Commerce and Industry for Job Front desk.
- VTI will provide the data of all the trainees passed outs in different trades.
- VTI will provide the skilled labour as per requirements of the in line with the demand of the industry.
- VTI will provide the Trade wise data of the trainees.
- VTI will impart the training in those trades which are dire need of the GCCI also.

5. Role of the Gujranwala Chamber of Commerce and Industry:

Following activities may be conducted on mutually agreed terms and conditions:

- GCCI will provide the job desk portal for trainees.
- GCCI will provide the assistance for the linkage of industries.
- GCCI will help the jobs to the passed outs as per the requirements of industry.
- GCCI will recommend/suggest highly demanded trades in the industry/market.
- The Area Manager shall ensure implementation of the **MOU** through chamber of commerce.

MISCELLANEOUS PARAMETERS






