6. **1. Terms and Conditions of MOU**

1.1. Subject to the provisions of this MOU, **GCCI** shall make available to **Roshni Homes Trust** the following from the date of execution of this MOU.

1.1.1. Training to the FRPR team of RHT, its Alumni and other administrative and management staff (collective called Participants).

1.1.2. Online workshops sessions on different subjects

1.1.3. Internship opportunities for RHT Students for a minimum period of 3 months

1.1.4. Proper job placement after internship or graduation

1.1.5. Hands on during the journey and look at industry's best practices and techniques.

1.1.6. GCCi should provide space for Roshni Homes Trust Add in your Annual Diary

2. The **GCCI** shall be sharing all details of the training modules and schedule prior to the training in advance.

3. **Roshni Homes Trust** shall be responsible for logistical arrangements to ensure efficiency of industry partnership initiatives.

4. Both Parties are bound to seek approval prior to sharing any images on social media platforms as well as promoting ads on any digital and traditional media platforms

5. Confidentiality

5.1. Both Parties recognize that it may become privy to confidential information proprietary to RHT, and duly warrants that any such material or information which may come into the knowledge, or possession, of RHT shall not be disclosed or revealed to any third party or utilized for its own benefit and such receipt of information and the manner in which it was received, shall be immediately communicated to **ROSHNI HOMES TRUST**.

6. The **Roshni Himes Trust** shall provide the **GCCI** details of participants for Trainings, Internships. **GCCI** shall not use the said data for any other purpose except above mentioned.
