MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) (hereinafter referred to as the "Agreement") is made on Monday 21st of August 2023.

Between

THE GUJRANWALA CHAMBER OF COMMERCE AND INDUSTRY; registered under the Laws of Pakistan (hereinafter referred to as the **GCCI**)

And

The Millennium Universal College (hereinafter refer to as **The Millennium Universal College Placement Office/Career Development Centre**).

This Memorandum of Understanding (MOU) aims at establishing a long term, sustainable and mutually beneficial cooperation in areas of bilateral interest for promoting research, industrial linkages, training, education, and employment opportunities between **The Gujranwala Chamber of Commerce & Industry** and **The Millennium Universal College Pakistan**.

1. Mutual Agreements

- 1.3. **The Millennium Universal College Placement Office** is obliged to acknowledge the participation / inclusion of **the GCCI** in relevant events, job fairs, seminars, workshops, guest lectures, trainings, mock interviews, professional grooming sessions, career counseling sessions, industrial / educational visits, publications, websites, media, and publicity campaigns with prior consultation and agreement with **the GCCI**.

1.4. The **GCCI** and **The Millennium Universal College** will grant permission for publication of either Partner's name and logo for promotional purpose in brochures, magazines, all marketing materials, photographs, pamphlets, news reports, promotion, publication, websites etc., in consultation and prior agreement of the **GCCI** and **The Millennium Universal College Placement Office** case to case basis.

1.5. **The Millennium Universal College** shall grant a **15%** tuition fee waiver on the **IMBA** (International Master of Business Administration [University for the Creative Arts]) Programme and **25%** on other Programmes being offered for the members of the **Partner Organization** and their **Children**.

3. Period of Validity

This **Memorandum of Understanding (MOU)** is effective till (tentative) day of May, 2025, until terminated with mutual agreement. In addition, it can be further extended with mutual consultation of **Partner Organization** and **The Millennium Universal College (TMUC)**

4. Modification of Clause and Article

Upon bilateral negotiation between **Partner Organization** and **The Millennium Universal College**, the **Memorandum of Understanding (MOU)** can be modified, revised, postponed or appended.

5. Confidentiality

The **Partner Organization** and **The Millennium Universal College Pakistan** must keep confidential, any and all unpublished information made known during the course of the **Agreement** and not disclose / publish any report(s) or paper on the basis of information obtained from **Partner Organization** and **The Millennium Universal College TMUC** except with the prior written approval and authorization of either **Partner Organization** and **The Millennium Universal College Placement Office**.

6. Dispute Resolution

In case of any dispute / conflict for the implementation of this **Memorandum of Understanding (MOU)**, both **Partner Organization** and **The Millennium Universal College** shall amicably try to resolve all matters through arbitrators.






