- The UK Pakistan Chamber of Commerce & Industry agrees to:
 - Assist in arranging meetings, and networking opportunities for visiting delegations from Gujranwala Chamber of Commerce & Industry.
 - Extend necessary support in facilitating B2B meetings and events in the United Kingdom.
 - Coordinate with local businesses and stakeholders to ensure the success of joint initiatives.

This MoU shall come into effect upon the date of signing and remain valid for a period of **1** Years, unless terminated by mutual agreement.

The parties agree to periodically review the effectiveness of this MoU and may make amendments or additions as deemed necessary by mutual consent.

Both parties shall maintain the confidentiality of sensitive information exchanged during the collaboration and agree not to disclose such information without prior consent.

Either party may terminate this MOU at any time with a written notice of 180 calendar days to the other party.
