

**MEMORANDUM OF UNDERSTANDING**

**1. PURPOSE**

**1.1** The purpose of this MOU is to establish terms and conditions where under the Diagnostic Centre will provide In-house laboratory and imaging services (the "services") to the **members & their dependents (including themselves, spouse, real children & real parents)** referred by the client (hereinafter referred to as the "Patients") as required.

**2. TERM**

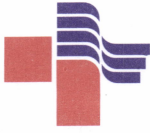
**2.1** This MOU shall be valid from the effective date for One (01) Year and shall remain in effect for unless terminated earlier by either party by giving one month's prior written notice to the other party.

**3. RESPONSIBILITIES OF THE DIAGNOSTIC CENTRE**

**3.1** The Diagnostic Centre will provide services to the **patients** referred by the Client in accordance with this MOU.

**3.2** The Diagnostic Centre will do its utmost to provide the Services within the scope of this MOU. However, if any or all of the Services are not available because of being utilized at full capacity then non-provision of such Services will not be considered as a breach of this MOU by the Diagnostic Centre and the Diagnostic Centre shall have no liability in this regard.

**3.3** The Diagnostic Centre reserves the right to revise the Regular rate list.

**3.4** The Diagnostic Centre will endeavor to accommodate the Patients for the agreed Services at all proposed centers with available facilities.

#### **4. RESPONSIBILITIES OF THE CLIENT**

**4.1** The Client agrees that the Patients referred by it will honor and follow the policies, rules and procedures made from time to time by the Diagnostic Centre.

**4.2** Patients can collect their records personally (upon positive proof of identification) or through their authorized representative with a letter of authority & the service receipt provided by the Diagnostic Centre for this purpose.

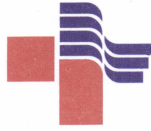
#### **5. PRICE AND PAYMENT**

**5.1** The Diagnostic Centre will extend its services to the patients upon presentation of **Membership Card/Referral Letter** & Relationship proof on **Cash terms**.

**5.2** The Diagnostic Centre will provide discount to the Client on **General Rates**. Details are given below.

- **In-House Laboratory Services = 25% Discount**
- **In-House Imaging Services = 20% Discount**
- **Covid-19 = As per actual**
- **Outsource Tests = As per actual**
- **Payment mode = Cash Terms**

The discount will be offered on published rate list which will automatically be revised when IDC revise it rates.



## 6. ASSIGNMENT

6.1 The rights and obligations of the Client are not assignable to any third person, without the prior written consent of the Diagnostic Centre.

## 7. AMENDMENT

7.1 Either party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the Parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by all parties to this MOU.




