Memorandum of Understanding

&

Chaman Chamber of Commerce and Industry

A memorandum of Understanding made on this day of March 9, 2021 between Gujranwala Chamber of Commerce & Industry (GCCCI) Chamber Plaza Aiwan E Tijarat Road Gujranwala herein after called "GCCCI" (which expression shall, unless repugnant to the context include its successors in interest and assigns) of the one part.

And

The Chaman Chamber of Commerce & Industry (CCCI) called the CCCI (Which expression shall unless repugnant to the context include its successors in interest and assigns) of the other part.

Whereas, the GCCCI being a representative body of the industrial and commercial sector in Gujranwala having the objective of the private sector in Gujranwala and promoting on environment conducive to national economic development within a framework of sustainable social equity and looking forward to venture further to promote the corporate / Industrial / commercial sector of both chambers desiring to become reciprocal partners and extend all support, co-operation and assistance to each other for the overall benefit of both organizations.

Now, it is mutually agreed by and between the parties as follows:

1. Chaman Chamber of Commerce and Industry will facilitate members of GCCCI for investment in special economic zone being developed in Chaman, whereas, GCCCI will extend technical support for its establishment.
2. Common Boarder market of Pakistan and Afghanistan is being set up Chaman Boarder where's Chaman Chamber of Commerce and Industry will facilitate GCCCI members for setting up shops, Warehouse and Exports of products to Afghanistan and central Asian states.
3. To facilitate co-operation between GCCCI and CCCI in promoting trade and industry in respective areas of both the Chambers. GCCCI & CCCI will improve the inter-Chambers interaction for trade industry and export-oriented activities.
4. Both the GCCCI & CCCI will promote trade delegations in areas of common interest to boost the trade in both countries.
5. GCCCI & CCCI will improve the inter-Chambers interaction for trade industry and export-oriented activities.
6. To facilitate members of both the chambers in their search for any business information in both the countries.

7. Regular exchange of documents and publications on economic and commercial issues and other matters of mutual interests produced by the two chambers.
8. Exchange of Information and technical expertise necessary for establishment of data banks at the two organizations.
9. Both the Chambers will support each other for the promotion and development of social compliances for industries in both countries through their R&D Department.
10. GCCCI & CCCCI will do their best to eliminate any obstacles that may hinder the trade and business development by identifying the barriers and finding the suitable solutions.
11. GCCCI & CCCCI shall exchange publications, magazines, periodicals, and data for their respective business communities.
12. GCCCI & CCCCI will assist each other in organizing and or participating in trade fairs and exhibitions held in local / national / international levels.
13. GCCCI & CCCCI will encourage joint research activities wherever possible and required.
14. Unless otherwise agreed, each party shall bear the costs and expenses for its participation in different activities which shall be subject to the availability of funds, personnel and other resources.
15. Both chambers will constitute a committee to resolve the trade disputes.

This MoU is valid for three years, and may be revised/ withdrawn with one-month prior written intimation.

Representatives of GCCCI and CCCCI shall meet, through email/ Phone calls/ video conferences from time to time to review the progress made in achieving the objectives of this Memorandum and to consider ways in which these provisions can be more effectively and efficiently implemented.


